Bank Leumi le-Israel Ltd. hereby announces that on 9 January 2014, Migdal Holdings for its nostro account, Public Company No. 52-0029984 ("Migdal (Nostro)"), informed it of the following:

On 8 January 2014, it purchased 1,000,000 nominal value of Securities No. 7410152, Leumi Finance Ltd. Subordinated Notes (Series G), in a stock exchange transaction, at a price of 131.2546 agurot.

In light of the above, Migdal (Nostro) holds a total of 39,875,587 Subordinated Notes (Series G) of Leumi Finance Ltd., which constitutes 1.99% of the entire series.

And on 8 January 2014, it sold 826,616 nominal value of Securities No. 7410244, Leumi Finance Ltd. Subordinated Notes (Series N), in a stock exchange transaction, at a price of 115.7356 agurot.

In light of the above, Migdal (Nostro) holds a total of 18,101,650 Subordinated Notes (Series N) of Leumi Finance Ltd., which constitutes 0.97% of the entire series.
