Bank Leumi le-Israel Ltd. hereby announces that on 25 March 2014, Harel Insurance Investments and Financial Services Ltd. for its nostro account, Public Company No. 52-0033986 ("Harel (nostro)"), informed it of the following:

On 24 March 2014, it sold 8,787 nominal value of Securities No. 7410202, Leumi Finance Ltd. Subordinated Capital Notes (Series 300), in a stock exchange transaction, at a price of 136.70 agurot.

And on 24 March 2014, it sold 37,097 nominal value of Securities No. 7410160, Leumi Finance Ltd. Subordinated Notes (Series H), in a stock exchange transaction, at a price of 134.31 agurot.
