Bank Leumi le-Israel Ltd. hereby announces that on 27 January 2014, Harel Insurance Investments and Financial Services Ltd. for its nostro account, Public Company No. 52-0033986 ("Harel (nostro)"), informed it of the following:

On 26 January 2014, it purchased 1,810,000 nominal value of Securities No. 7410186, Leumi Finance Ltd. Subordinated Notes (Series J), in a stock exchange transaction, at a price of 119.11 agurot.

In light of the above, Harel (Nostro) holds a total of 17,938,586 Subordinated Notes (Series J) of Leumi Finance Ltd., which constitutes 0.9% of the entire series.

And on 26 January 2014, it purchased 2,144,016 nominal value of Securities No. 7410228, Leumi Finance Ltd. Subordinated Notes (Series L), in a stock exchange transaction, at a price of 116.86 agurot.

In light of the above, Harel (Nostro) holds a total of 25,317,918 Subordinated Notes (Series L) of Leumi Finance Ltd., which constitutes 0.77% of the entire series.
