Bank Leumi le-Israel Ltd. hereby announces that on 30 June 2013, Migdal Holdings for its nostro account, Public Company No. 52-0029984 ("Migdal (Nostro)"), informed it of the following:

On 26 June 2013, it sold 300,000 nominal value of Securities No. 7410152, Leumi Finance Ltd. Subordinated Notes (Series G), in a stock exchange transaction, at a price of 128.9690 agurot.

In light of the above, Migdal (Nostro) holds a total of 17,837,043 Subordinated Notes (Series G) of Leumi Finance Ltd., which constitutes 0.89% of the entire series.

On 27 June 2013, it sold 1,00,000 nominal value of Securities No. 7410228, Leumi Finance Ltd. Subordinated Notes (Series L), in a stock exchange transaction, at a price of 115.2620 agurot.

In light of the above, Migdal (Nostro) holds a total of 9,917,107 Subordinated Notes (Series L) of Leumi Finance Ltd., which constitutes 0.3% of the entire series.
