

## Re: **Dismissal of Appeal**

Bank Leumi le-Israel B.M. (hereafter – the "Bank") is pleased to report as follows:

- 1. As described in Note 26.D.1 1.1.A to the Bank's financial statements as of December 31 2019, which were published on February 26 2020 (Ref. No. 2020-01-019488), in an immediate report of June 22 2020 (Ref. No. 2020-01-064956) and in an immediate report of July 7 2020 (Ref. No. 2020-01-064729), a motion for class action certification was filed against the Bank and other banks on June 5 2019. On June 21 2020, the District Court handed down a ruling ordering dismissal in limine of the motion for class action certification, and on July 6 2020 the applicants submitted to the Supreme Court an appeal against the said District Court ruling.
- 2. On August 25 2021, the Supreme Court handed down a ruling dismissing the appeal and imposing the payment of the respondents' expenses by the applicants.
