Re: Motion for Class Action Certification

Bank Leumi le-Israel B.M. (hereafter – the “Bank”) is pleased to report as follows:

1. On June 07 2021, a motion for class action certification was filed against the Bank to the Center District Court.
2. The motion deals with the applicants' claim whereby the defendant caused him damage by presenting a balance that was not up-to-date in his bank account over a two-day period from the date on which the applicant purchased foreign securities and the date on which his account was debited in respect of the purchase.
3. The applicant estimates the personal damage caused to him at NIS 35 thousand and does not specify the damage amount caused to the entire group.
