Re: Appeal against a Judgment Rejecting a Motion to Approve a Class Action Lawsuit

Bank Leumi le-Israel B.M. (hereinafter: the "Bank") is hereby reporting as follows:

As detailed in Note 26.C. 1.3 a. to the Bank's financial statements as of December 31 2020, published on March 9 2021 (Ref. No. 2021-01-029400) and as detailed in an immediate report dated April 30 2015 (Ref. No. 2015-01-009684), on April 29 2015, a motion was submitted for approval of a claim as a class action against the Bank. As detailed in the abovementioned note and as detailed in an immediate report dated February 14 2021 (Ref. No. 2021-01-018073), on February 11 2021, a judgment was handed down by the District Court rejecting the motion for approval of the claim.

On April 12 2021, the plaintiffs filed an appeal against the judgment with the Supreme Court.
