On September 13 2021 the Bank's general meeting decided to appoint Mr. Elya as an ED in accordance with the Companies Law, 1999 (hereinafter – "ED") for a period of 3 years. Mr. Elya's term in office will start subject to the approval or non-objection of the Banking Supervision Department, and subject to what is stated in Section 2.1.15 to the report convening the general meeting, which was published on August 5 2021 (Ref. No.: 2021-01-127997).

On October 28 2021 a notice was received as to non-objection on behalf of the Banking Supervision Department to the appointment of Mr. Elya as an ED in the Bank. Accordingly, Mr. Elya's tenure as ED in the Bank started on November 1 2021.
