**Re: Trustee's 2019 Report for Holders of Series N Subordinated Bonds of Bank Leumi le-Israel B.M.**

In our capacity as the trustee for Series N subordinated bond holders (hereinafter – the “**Bonds**”) issued by Bank Leumi Finance Company Ltd. (hereinafter – “**Leumi Finance**”), we are pleased to file an annual report in respect of actions executed by us during the period from January 1 2019 through December 31 2019 (hereinafter – the “**Reported Period**”) in accordance with the provisions of the Deed of Trust, Section 7 of the Trust Law, 1979 and Section 35H1 of the Securities Law, 1968.

**The Deed of Trust**

On November 14 2011, Leumi Finance issued Series N Subordinated Bonds for the first time.

On January 4 2015, the merger of Leumi Finance with and into Bank Leumi le-Israel B.M. (hereafter – the “**Company**”) was completed. As part of the merger, Leumi Finance was dissolved and merged with the Company. Since then, the Company is viewed as having replaced Leumi Finance for all intents and purposes.

The Bonds are not secured by any collaterals.
